



### TOGETHER, FORWARD

Spaulding was established 54 years ago in response to the belief that every child had the right to grow up in a safe and permanent family. Today, Spaulding continues to hold true to the mission and core values of our founders. Through our three divisions, the Agency continues to deliver services and develop products that are designed to equip foster and adopt parents with knowledge, skills and competencies needed to ensure children grow up in a safe and permanent home and have the help they need to succeed.

Despite the many challenges still posed by COVID-19, this Annual Report to Our Community provides an overview of our work and how we continue to fulfil our mission. Even with the COVID related challenges impacting foster care and adoptive services, the members of the Spaulding team have continued to provide what is needed for each child and family in our care.



### MR. MICHAEL GENE "MIKE" LUCCI (1939-2021)

We dedicate our 2021 Annual Report to Michael Gene "Mike" Lucci, longtime supporter of Spaulding for Children. The Detroit Lions star, businessman, sportscaster, and philanthropist died October 26. We remember him as a great human being who did all he could to help children and our Agency without expecting anything in return.

Mr. Lucci became an advocate of Spaulding for Children during a Lions pre-season training camp circa 1970. Several children from Spaulding had been invited to watch practice and afterwards asked if they could carry his helmet and shoulder pads to the locker room.

A short time later, while at a dinner with his friends and golf partners, Mr. Lucci talked about the kids

he had met. "How can we help?" they asked. Mr. Lucci opened his checkbook and made out a draft. All present did the same. Their generosity soon became the Mike Lucci Golf Tournament, which raised more than \$2 million over a 30-year period.

Mr. Lucci also established an education endowment fund for the children served by Spaulding, the Michael G. Lucci Education Endowment Fund, in memory of his father, the late

In 2019, Mr. Lucci became the first recipient of the Spaulding for Children Ambassador Award, given in recognition of his service on behalf of children and Spaulding for more than 30 years. The honor is now the Mike Lucci Ambassador Award.

### ALL THE DIFFERENCE IN THE FUTURE

Jessica Harris-Loudd remembers the exact moment a magistrate ordered that she and her 12 siblings be removed from the custody of her mother. It was the instant she knew what she had to do.

"I needed to make sure we all stayed together," Ms. Harris-Loudd said. "We are a family."

It was Ms. Harris-Loudd's first time in a Michigan courtroom. It also was her 13th birthday.

As the second oldest in her biological family, and as the oldest girl, Ms. Harris-Loudd already was becoming an expert at child care, cooking and performing many of the other important aspects of keeping a home. She has an older brother, but he had already moved out of their mother's home.

Two aunts stepped forward and served as foster/kinship parents for the children. While they were in separate homes, they still could be together, along with their biological mother.

"That birthday in court also was the first time I heard of Spaulding for Children," Ms. Harris-Loudd said. "They were there for me and my siblings then, and they've been a part of who I am ever since."

Three years to the day after that first time in a Michigan courtroom that removed her and her 12 brothers and sisters from their parent's custody, Ms. Harris-Loudd was formally adopted by her aunt. It was her 16th birthday.

Ms. Harris-Loudd credits Spaulding for Children for helping them stay together as a family. Spaulding provided guidance, resources and expert care that helped keep her siblings together. Spaulding also helped her identify scholarships for college and recommended Jessica to a special program at Schoolcraft College that provided support for adoptive and foster students.

Through Spaulding scholarships, including support from the Michael G. Lucci Education Endowment Fund,

Ms. Harris-Loudd was able to study culinary arts and later criminal justice, earning two associate degrees.


Ms. Harris-Loudd originally had planned a career in the Department of Homeland Security or in the United States Navy or Air Force, but asthma kept her from military and police service. So, Jessica determined she would develop her entrepreneurial abilities. She capitalized on her striking physical appearance, serving as a fashion model. She also enrolled in cosmetology school and began to plot a career providing beauty services to clients out of her home. She plans to open her own salon in the near future.

The team at Spaulding for Children saw her as an inspiration for others

and asked her to talk to high school age children who were in similar circumstances. Today she participates with DreamTek, an organization devoted to helping children from foster care and other challenging backgrounds explore career and educational possibilities. She also serves as a mentor to children in foster care, helping them know they are not alone on their path to adulthood.

"Everyone has a choice," Ms. Harris-Loudd said. "You don't have to be like your parents or anyone else. The future can bring limitless possibilities. Thanks to Spaulding and all the people who have cared for me and my siblings, I know that is true."





### **HOW WE BUILT STRONG FAMILIES**

- We kept children from entering foster care by teaching and supporting their parents to safely care for them in their homes.
- We supported and empowered families to overcome their challenges and eliminated safety concerns so that their children could be safely reunited with them.
- We provided mentoring support for foster youth.
- We provided Personal Protection Equipment and household goods, grocery gift cards and supplies to families during the pandemic.
- We built relationships with the community and partnered with business organizations.
- We found permanent families for children and youth who needed one; they are now thriving in the care of their adoptive families.
- We provided scholarship funds to support foster youth interested in higher education.
- Through national grant projects, we created products and materials to equip families caring for children with a history of trauma.

### H-BASS & UIA

HOSPITAL-BASED ADOPTION SUPPORT SERVICES PROJECT & UNDERSTANDING INFANT ADOPTION

The Hospital-Based Adoption Support Services (H-BASS) is a federal grant to help ensure pregnant women who wish to place a child for adoption have access to well-trained staff and comprehensive supports in hospital settings throughout the adoption process.

H-BASS team reached out to 3,699 individuals in approximately 1,850 hospitals in the 43 states.





### NTDC

#### THE NATIONAL TRAINING AND DEVELOPMENT CURRICULUM FOR **FOSTER/ADOPTIVE PARENTS**

The National Training and Development Curriculum (NTDC) is a federal grant to develop, implement and evaluate a curriculum that will prepare and provide ongoing training to foster and adoptive parents to effectively parent children exposed to trauma, separation or grief and loss.

Jessie Howell, a foster parent for over 10 years, has been a participant of

NTDC. She shares, it's not just about what's covered in class. "What NTDC teaches you is that this is a journey. It's like college - they don't teach you everything, they teach you how to learn. If you think you have it all down, you probably don't. Parents leave NTDC knowing this will be hard, but have some tools and know where to go.

### **MPLD**

#### THE MINORITY PROFESSIONAL LEADERSHIP DEVELOPMENT

The AdoptUSKids MPLD is a component of a federal grant to implement a 12-month fellowship program designed for emerging minority leaders working in the adoption field.

The project continues to strive to impact states, tribes, and territories across the nation. To date, 50% of MPLD alumni have been promoted either during the fellowship or shortly after.
